Please note that only life members and annual paid members will be allowed to vote. Please note annual paid members must have continued membership for 3 years including current year to VOTE, i.e 2021/22. 2022-2023 & 2023-2024 (3 years membership)

After the closing date 1st July 2023 (8pm), the Election Team (selected by the Managing Trustees) will shortlist the candidates after vetting. This will be displayed on Mandir and HCC notice boards and will be displayed on WDHA website and WDHA Facebook page. Voting will be done on the day of AGM 16th July 2023 during agenda item 16.
